



## 2023 A7FL NV Football Contract

Be known that on **the below listed date**, the undersigned player herein referred to as **PLAYER** and **A7FLNV, LLC** herein referred to as **LEAGUE**; have entered into an agreement on the following matters:

The **PLAYER** contract with the team indicated below, herein referred to as **TEAM**, starts March 26, 2023 and runs through the end of the 2023 season, unless an extension of that season is continued due to “playoffs” and or “championship play”. The **PLAYER** understands that the **LEAGUE** does not permit in-season trades or transfers. **PLAYERS** are released immediately if they present a signed intent / contract in the AFL, IFL, CFL, XFL, USFL, NFL. **The LEAGUE** is designed to develop players so that they can ascend in their respective careers.

**PLAYERS** who join the **LEAGUE** are unpaid. **PLAYERS** who play with **LEAGUE** will have individual and team opportunities to make potential monies through sponsorship(s) and donations.

**PLAYERS** agree to play at their own risk and in conjunction with their contract, **PLAYER** will sign a 2023 **LEAGUE** Release of Liability. By signing this football contract, release of liability and the code of conduct, the **PLAYER** releases and discharges the **LEAGUE**, its owners, workers, the A7FL league, officers, coaches, directors, volunteers, officials, medical staff, vendors, venues and sponsors of any and all known and unknown actions, suits, and demands whatsoever in law and equity including but not limited to the risk of injury from participating in the 2023 season.

Regarding medical insurance, if a **PLAYER** chooses, a **PLAYER** can sign up with a third-party vendor and can receive medical insurance through an insurance company at a reduced cost. An additional carrier ProAM Sports Medicine will give **PLAYERS** affordable healthcare coverage for an annual fee. If a **PLAYER** chooses any of these insurance groups, they will be put in contact with these groups’ main representatives to fill their insurance needs. **PLAYERS** are encouraged to have medical insurance whether through their employers, family employers, etc.

In the event of an injury occurring, you authorize the **LEAGUE** to transport you and to seek medical treatment for you by signing this agreement as well. If the injury falls within concussion protocol, the **PLAYER** needs an official doctor, physician, and or medical release to participate in any **LEAGUE** football games. This needed medical release is used for the immediate health and safety of the **PLAYER**.

## Equipment Agreement

**PLAYERS** who join the **LEAGUE** and register with the A7FL will be provided during the football season the following from the **LEAGUE** or **TEAM**: Game jersey and pants. The uniforms are owned by **LEAGUE** or **TEAM**, unless individually purchased from the **TEAM** or the **LEAGUE**.

**PLAYERS** are allowed to purchase their own soft head protection (2nd Skull cap), which is the only protective head gear approved by the A7FL. **PLAYERS** can also purchase and wear their own soft protection equipment, which will be worn under the uniform such as: padded girdles and padded undershirts. No hard pads are permitted.

After each game, **PLAYERS** will return any league owned jersey and game pants for laundry services. Uniforms will be returned to the **PLAYERS** on game day. At the completion of the entire season, **PLAYERS** will return league-owned game football uniforms (jersey and pants) to the **LEAGUE**. **PLAYERS** will be given the option to purchase a custom jersey/uniform throughout the season at a cost of \$50 plus shipping and handling.

## Team Membership of Player

The following rights and privileges are matters of value to the **PLAYER**. Any additional privileges afforded to the **PLAYER** are not included in this agreement unless done so in writing.

1. **PLAYER**, by signing this agreement, shall become a roster member of **TEAM/LEAGUE** for the duration 2023 Spring season commencing on the date of execution of this agreement.
2. **PLAYER** shall be listed as a roster member of **TEAM/LEAGUE** in all official publications by **LEAGUE** or by the A7FL.
3. **PLAYER** shall have the right to inform third parties that they are a member of the **LEAGUE**, and have a right to access all **TEAM/LEAGUE** practices, meetings, and gatherings unless otherwise prohibited in this agreement.
4. **PLAYER** shall have the right to play as a member of **LEAGUE** in a manner determined by the Head Coach of the **TEAM**. **PLAYER**, unless prohibited by the Player Code of Conduct, shall always have the right to suit up for a game, unless overriding equipment of safety issues prevent such action.
5. Any **PLAYER** in good standing shall have the right to practice as a member of the **LEAGUE**.

## Player Rights Granted to Team

**PLAYER** grants **LEAGUE** perpetual rights and license in regards to the **PLAYER'S** likeness, image, name, and all other rights held by the **PLAYER** for any legal purposes **LEAGUE** may choose to utilize. A **PLAYER** shall not have these rights separate from **LEAGUE**. The rights include but not limited to:

- 1) Sale of merchandise related to **PLAYERS** likeness.
- 2) Usage of **PLAYERS** name or likeness for the purposes of advertisement.
- 3) Sale of entertainment rights of **PLAYER**.
- 4) Sales of rights to this contract

**PLAYER** agrees that they may not sign with or be a member of any other team; in any league level or football during the 2023 season without a verbal conversation of agreement with **LEAGUE** management.

**PLAYER** agrees to show up to practice at the assigned places and times unless otherwise excused by the **TEAM** staff.

**PLAYER** agrees to appear at events, engagements, and games in a timely manner and in a prepared and professional state, unless otherwise excused by **team or LEAGUE** staff.

All **PLAYERS** who sign a **PLAYER contract**, Code of Conduct, and Injury Release Waiver with the **LEAGUE** agree to exemplify great sportsmanship at all times. These games will be recorded live and replayed, along with being streamed live through the A7FL national links for countless people, including football scouts, and the A7FL League to view.

Absolutely zero tolerance for fighting, excessive verbal language with verbal battering, drug use, or alcohol usage during any **LEAGUE** events such as: games, practices, meetings, or any team functions. Additionally, any **PLAYER** who commits a felony at **ANYTIME** while signed as a member of the **LEAGUE** will be suspended indefinitely and the **LEAGUE** Board of Directors will be notified.

## Drug Policy

As member of the **LEAGUE**, **PLAYER** agree, that they will be free of illegal use of drugs and narcotics. A violation of this team rule may result in immediate and indefinite dismissal from the **LEAGUE**. See Code of Conduct for Discipline.

## Injury Policy

**PLAYER** acknowledges having received, read, and signed a Release of Liability form prior to having executed this contract. **PLAYER**, hereby affirmatively incorporates that attached Waiver into this agreement and affirms their understanding of risks associated with membership to the **LEAGUE**.

**By signing this 2023 A7FL NV Football Contract, I fully acknowledge that I have read and fully understand the terms of this agreement.**
