- Individual Release forms are required for each athlete, coach, official, vendor, performer and staff member.
- All athletes, vendors and staff age under 18 must have a written Release signed by parent or legal guardian.
- No gum, food or eating allowed on the field turf.
- Athletes, coaches, officials, vendors, performers and staff will stay home when feeling ill or are displaying any COVID-19 symptoms. Event Organizer and Fieldhouse Staff, have the right to refuse participation by any spectator, participant, athlete, coach, official, vendor, performer or staff showing any signs of any illness.
- Violation of any of the rules may result in removal from the Facility. Repeated violations could result in suspension up to removal from all future events.
- I have read and understand the rules and bylaws posted on the www.andersonautogrouffieldhouse.com and agree to abide by all rules and bylaws and understand failure to do so may result in the removal from the contest and or the facility.

Each participant agrees to the following:

I am at least 18 years of age, acting for myself and/or acting on behalf of a minor under 18 years of age, for whom I am the parent/legal guardian. In consideration of my opportunity to participate, I agree to this Participant Release ("Release") as follows:

There is inherent risk in participating in large organized athletic events. By participating as a member of this event ("EVENT"), I agree to assume all risk of injury, illness, death or loss of property from whatever causes arising during my participation. I understand the Anderson Auto Group Fieldhouse ("AAGFH") and the Colorado River Union High School District ("CRUHSD") does not provide any type of insurance for participants, including illness, severe illness or accident insurance.

In consideration for the opportunity to participate as a member of the EVENT, I agree to waive, release, and indemnify, defend and hold harmless at my own expense, the CRUHSD, AAGFH, City of Bullhead City, Mohave County, the State of Arizona, the United States of America, all sponsors, organizations, individuals or volunteers assisting with any phase of the EVENT, and their employees, agents, officers, successors or assigns, from liability for any claim, action, loss, liability or suit for damages of any kind arising out of my minor's participation in this EVENT in any capacity. I understand that this Release is binding upon my heirs, personal representatives, administrators, successors and assigns and those of the released parties. This Release also serves as my permission for use of any images taken of me during the season and my waiver of any compensation for their use by the CRUHSD, AAGFH or its assigns for any promotional or official CRUHSD or AAGFH purposes.

I understand and agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Arizona, and that if any portion is held invalid, I agree that any remaining portions will continue in full force and effect.
